

FACT SHEET: Social Assistance Rates

1% Increase Effective November / December 2011

The table below shows benefit rate amounts for select Ontario Works (OW) and Ontario Disability Support Program (ODSP) family types before and after November / December 2011, to reflect a 1% increase in Basic Needs and Maximum Shelter rates. The increases will appear on ODSP cheques received in November and OW cheques received in December 2011.

The Ontario Child Benefit (OCB) is also payable to families with dependent children. OCB amounts are included here to provide a sense of total maximum monthly income from these provincial sources. The 1% increase also applies to the Double Disabled rate, Northern Allowances, the Special Boarder Allowance, the Guide Dog Benefit, the **Personal Needs Allowance**, and benefits for Board and Lodging, Dependents of Dependents, Residents of Interval and Transition Homes, Advanced Age, and Temporary Care Assistance. The Assistance for Children with Severe Disability (ACSD) amount will be increased to \$450.
